All faculty members, researcher scholars and students (PG) from different disciplines are cordially invited to present their research papers in the conference.

FOCAL THEME

Sustainable development is a complex concept that is embedded in the concern for the environment. In time, it has been enriched with an economic and a social dimension. In the beginning, sustainable development was meant to be the solution to the ecological crisis caused by heavy industrial exploitation of resources and continuous environmental deterioration. Its main goal was to preserve the quality of the environment. At present, the concept of sustainable development also embraces the quality of life both from the economical and the social perspective. The main concern of the sustainable development strategy is the human community in space and time and the creation of a cohesive system that is able to cover the costs generated by economic-social growth, pollution prevention and its negative effects.

Sustainable development has various dimensions – ecological, economic and educational as well as sociological. The ecological dimension is concerned with sustainable consumption and production, natural resource preservation and management, climate change and clean energy. The economic dimension deals with socio-economic development and sustainable transport, while the social dimension envisages social inclusion, demographic changes, cultural lag and public health. Underestimating the role of social factors in sustainable development will endanger development programmes and projects.

The sociological dimension adds two sets of elements to sustainable development. In the first place, it provides a number of concepts that help in explaining social actions, human relations, the complex forms of social organisation, institutionalised arrangements and culture, motivations, incentives and values that shape man's attitude towards his fellow creatures and natural resources. In the second place, it provides social methods for the prompt coordination of social actions and acts as a barrier against harmful behaviour, stimulating association, alternative social arrangements and social capital development. Programme planners in search of sustainability are often unaware of the cultural mechanisms that can be used to encourage social dynamism and coordinate actions towards development programmes. These tools vary from creating a public conscience to investing in human capital, from simple consulting activities to developing participatory management; from enhancing traditional values and old practices to introducing innovation; from authorisation to increased social cohesion to; from the individual behaviour determined by economic

motivations to exploiting the power of solidarity, self-organising confidence and group values.

The majority of political and intellectual leaders around the world acknowledge sustainable living concerns as top priority as sustainable development is the most important tool for protecting the biosphere and to secure the future. The debate on sustainable living concerns is driven by the effort to attain the ideals of humanism and the harmony between man and nature.

The physical and the social environment of human beings are interrelated. Our physical surroundings mediate, affect, inhibit and encourage our social and personal relationships. Every environmental setting induces feelings, associations and attitudes in the perceiver that may be described as its ambience. Humans react both consciously and unconsciously to their environment which has a profound effect on feelings, behaviour, general health issues and productivity.

In the context of contemporary society where environmental problems are increasingly threatening the sustainability of human existence, it is crucial that environmental psychology be given its due importance.

Research suggests that various factors may interact and cause or contribute to the development of mental health problems including physical, social, environmental and psychological factors

Human beings and their environments are in mutual transactional relationship. Human psychological processes cannot be understood without their environmental context and inversely, physical settings cannot be fully described without the psychological mechanisms inspiring them.

The objective of the seminar is to delve deeper into the human-environment interactions by exploring the psycho-social and environmental perspectives in an attempt to create, manage, protect and restore environment with an aim to promote sustainable behaviour.

SUBMISSION OF ABSTRACT & FULL PAPER

Authors are requested to submit their original research contribution in the form of an abstract with specified subtheme, not exceeding 300 words with maximum 5 key words, 1.5 spaced, 12 fonts, Times New Roman, justified on both sides. The abstract must carry the authors name, designation, affiliation, contact number with STD or ISD code (e.g. +91-980000000) and email id. The abstract must contain a brief introduction, objectives, methodology, database, major findings and keywords.

The authors may submit their full length paper after getting the letter of acceptance of abstract from the organizers. In that case the format of the full length paper will be the same as the abstract. The full paper must not exceed 7 pages including all the tables, diagrams, maps, references, title and particulars related to the author(s). It is highly expected that the contributions should be authentic as per the research ethics of anti-plagiarism.

PUBLICATION

The abstracts and papers will be accepted after the process of review by an expert committee and on the basis of their recommendations, selected number of papers will be published in an UGC enlisted referred journal namely, ***INTERNATIONAL JOURNAL OF INTEGRATED RESEARCH AND DEVELOPMENT*** (ISSN: 2278-8670). An additional charge of Rs. 1200/- (Twelve hundred) is needed for publication if a manuscript is accepted by the Editorial Board.
